

Phil Dean	Is it possible to get any help with running technique from within the club?	CiRF qualified trainers can provide help – there are a few in the club such as Aly and Louise. There are other friends of Arrows who provide similar services and also organisations such as Pose who offer courses. We will try and look at providing some 'intro' sessions in 2023.
Terry Atkinson	Are we going to have track nights back in Luton again v the grass track at KWS?	Yes - or at least we hope so. We have started already looking at costs and options for different track locations. We'll work out logistics and then we'll likely need help to manage and lead the sessions.
Ed Rhodes	Has any time been given to reviewing the start time on club nights (as working practices have changed)	We have certainly considered it, but we found attendance waning at the alternative and earlier sessions in 2022. However, we can do whatever gains most support, with the caveat we need appropriate run leader cover. We'll consult further in 2023.

#### Constitution – Application of Surplus Funds

Our Approach - can only apologise to have caused any issues or concerns.

- 1) Use similar wording to that which was proposed last year, but not adopted on a point of process / order
- 2) We were seeking to clarify the potential confusion in the existing wording in the use of "on winding-up or dissolution of the Club" as could be construed as applicable to both sentences in the phrase. It's not, but we did try to expand the potential to use funds beyond the existing remit – <u>all in good faith and in pursuit of the objects of the club</u>
- 3) Many of the suggestions have sought to restrict the discretion that the Committee already has perhaps either through:
  - a) Incorrect interpretation of what we already have
  - b) Perhaps giving the impression that we would deviate from the objects of the club
  - c) Poor wording of the new statement
  - d) Poor explanations in response to questions

Can only apologise to have caused any issues or concerns. We will have a vote this evening. If proposed words not suitable or believes gives more discretion than already available to pursue the objects of the club, please vote against it.

## Objects of the Club

- (a) principally to provide a **friendly and sociable environment in which adults of all ages and capabilities will find** encouragement and support for their jogging and running activities in Harpenden and the surrounding areas.
- (b) to provide other ordinary benefits of an amateur sports club as set out in Schedule 18 of the Finance Act 2002 including without limitation provision of suitably qualified coaches, coaching courses, insurance, medical treatment, post-match / post training refreshments;
- (c) to obtain funding for the activities of the Club by collecting entrance fees, membership subscriptions, by obtaining sponsorship and other available funding;
- (d) to affiliate to UKA and the National Association and any other association which the management committee consider to be beneficial to the club and its members;
- (e) to comply with and uphold the Rules and Regulations of the National Associate, UKA and the IAAF as amended from time to time and the rules and regulations of any body to which UKA is affiliated;
- (f) to acquire, establish, own, operate and turn to account in any way for the Members' benefit the facilities of the Club together with buildings and easements, fixtures and fittings and accessories as shall be thought advisable;
- (g) to make rules, regulations, bye-laws and standing orders concerning the operation of the Club including, without limitation, regulations concerning disciplinary procedures that may be taken against the Members;
- (h) to discipline the Members where permitted by its rules/regulations and to refer its Members to be disciplined by UKA or the National Association (as appropriate) where so required by the Rules and Regulations of UKA or the National Associate (as the case may be); and
- (i) to do all such other things as the Management Committee thinks fit to further the interests of the Club or to be incidental or conducive to the attainment of all or any of the objects stated in this Rule 3.

Application of Surplus Funds 4.1 The Club is a non-profitdistributing organisation. All surpluses will be used to maintain or improve the Club's facilities and in furtherance of the Club's objects. No surplus will be distributed other than to another community amateur sports club for athletics, to UKA for use in community-related athletics initiatives, or to a charitable organisation, on windingup or dissolution of the Club.

**Application of Surplus Funds** 4.1 The Club is a non-profit-distributing organisation. All surpluses will be used to maintain or improve the Club's facilities and in furtherance of the Club's objects. No surplus will be distributed other than to another community amateur sports club for athletics, to UKA for use in community-related athletics/sporting initiatives, or to a charitable organisation(1) at the discretion of the management committee or(2) at the recommendation of the management committee and majority approval of the responding members given 21 days notice or on winding-up or dissolution of the Club.

#### **Reason for Change**

Desire by the Management Committee to remove ambiguity from the current wording and permit some discretion to donate or fund sporting related activities that are deemed relevant to the club and its activities and interests.

## Members' Q&A Constitutional Matters

**Chas Andrews**: "Can you please answer the follow questions in relation to the proposed changes to clause 4.1 (the Application of Surplus Funds) of the Club's constitution?

#	Question	Response
1	Why does the committee feel it is necessary to have the ability to distribute the Club's surpluses in any situation, rather than just on winding-up or dissolution as the current constitution allows?	As well as the reasons given in the AGM notice, we felt that it is potentially a restrictive clause if strictly interpreted in isolation. We wish 'to provide a friendly and sociable environment in which adults of all ages and capabilities will find encouragement and support for their jogging and running activities in Harpenden and the surrounding areas'. We feel that this change supports that, especially in relation to a surplus.
2	Why does the committee feel it is appropriate that a simple majority of the committee can decide how the surpluses are distributed (as per "1" in the proposed text), rather than any distribution having to be agreed by members too (as per "2" of the proposed text)? The use of the word "or" makes the inclusion of "2" irrelevant.	The team feels that some further discretion would be preferred as the membership already entrusts the team with ongoing spend and other decisions. The team's duty to the club, its members and their interests are inherent in those people who volunteer and represent the club. (Re suggestions on wording: any edits, however minor, would require a re- consultation with all Arrows members and whilst could be changed, the impact in the management team's view is negligible so the wording won't be changed for the vote)
3	Why has the committee decided not to limit the percentage of any surpluses that can distributed at any one time whilst the Club is still active?	As it currently stands, it would be at the discretion of the collective team. The team consults within itself and frequently solicits opinions of club members to find the best solutions to most likely be acceptable to the club. We don't see this changing in nature and did not want to take a prescriptive approach as there are many variables to consider.

#	Question	Response
4	Why has the committee decided not to specify that any surpluses cannot be distributed to any entity with which a committee member has a personal connection?	We are not seeking to be so strict or prescriptive with our rules to prevent a distribution to such a connection if it could be to the benefit of the club. Typically, networks and connections can actually facilitate good ideas for the club, It is also typical that such connections are explored in discussion and a balanced approach is taken
5	Was this proposed change unanimously voted for by the committee, and if not how many people voted for and against it (without disclosing who voted which way)?	There is no requirement to disclose, but there were up to 3 meetings in which the items were discussed and the discussion document was available for up to 6 months for the management team to reflect upon. No objections or abstentions were received.
5	If the proposed changes are voted through at the AGM, a simple majority of the committee could decide to distribute the Club's entire reserves, which currently stand at over £16,000 (but could be significantly more in the future), to an organisation or charity with which they have a direct involvement. The members would be unable to prevent this. Does the committee really think that this is appropriate?	There is no intent in the current team to do this. The wording does mean such a decision <i>could</i> be made, but it is deemed unlikely given the nature, integrity and trust placed in the elected members of the committee. There are lots and checks and balances within the team to ensure fairness and sensible decisions - even if there is a connection to an organisation or charity to which someone is connected. By nature and in the proposed wording, important and material decisions would likely be deferred to the members for fear of the upset that any bad decisions would cause in the wider membership. The team's proposal for the AGM is to ask for approval for the current wording to confirm that discretion. Currently, there is ambiguity that we cannot legitimately award any surpluses to merited, charitable causes (sport or otherwise), but which could be of potential interest to members such as the Harpenden Trust, or Friends of the Nickey Line / Swan Walk or perhaps even anything that could be needed to ensure the track in St Albans remains open. Even the defibrillator donation given a number of years ago could be construed as contrary to the current wording. We would like to remedy this.


